Sunday, July 18, 2010

Present: Frank Powers, James Robertson, Dennis Desmond, Rick Presnell, Ron Valleroy, Paul D. Mayer, Robert Mallery, and Larry Harlan.

Frank Powers President called the meeting to order at 10:32 and welcomed everyone and welcomed the guest, Harrell E. Green, Judith L Green, Freeda Diaz, and Jerry Bryant. Frank mentioned that the conference coming up may be the best one yet and that there is a need for ideas on who should present and the speakers needed to make the conference successful. If you have ideas or suggestions please let Frank Powers know.

Frank commented that we have a vacant region in the Northwest and the bylaws say that we must have a director for each region and that the board may appoint someone. The Board should represent all members in the state. We are searching for ideas on the best way to handle this in the future. Frank wanted the Board of Directors to call him if they can't show and let him know which Deputy will be representing the Region for the Director.

Dennis Desmond presented the from April 18th, 2010 minutes of the MHEIA with a correction. **Motion to approve the Minutes with corrections was made by Rick Presnell and seconded by Bob Mallery. Motion approved.**

Frank Powers presented the Treasurers report because Don Harris was unable to attend the meeting. There was a balance of \$12,580.67. **Jim Robertson made a motion to approve the Treasurers Report with a second from Bob Mallery. Motion Carried. Report is attached.**

Frank reported that Jennifer Glenn is the Sales Manager (Holiday Inn Executive Center, 2200 I-70 Drive, SW Columbia, MO 65203, 573-445-8531) at the Hotel and that the Picadilly Room will cost \$350 each day for the use for the Conference and the larger room Windsor IV will be the main room for the meals and general sessions. Jerry Bryant and Paul Mayer will help Jim Robertson with the silent auction. Please contact Jim with silent auction items. We do need to search out vendors for the conference. There was a discussion on where we purchased the conference pins with possible contact with Don Harris for the address. Frank did talk to the Holiday Inn about the menu's for the conference. We also need to come up with ideas for member gifts at the conference. A block of 125 room nights had been made with the Hotel at \$89.95 plus tax. A suggestion was made to put up some banners and items related to MHEIA on the walls in order to make a more pleasant MHEIA connection.

Don Harris had emailed a reported stating that we have 248 as of July 15th which is up 32 members with 48 life. Forty one of these members are new members this year due to the one year comp membership that was responded to from the offer sent out in the MDC Newsletter. We still need to work on bringing in new members. This was a motion from the previous meeting in which **Jim Robertson made a motion to give a 1 yr. MHEIA Membership to new instructors with a second by Don Harris. Motion Approved.**
