C. To provide a forum where members can discuss issues, propose solutions, and solicit the support of the Association within the current guidelines of section 501 C 3 of the Internal Revenue Code.

D. To provide group exposure to state-of-the art trends in hunter education.

E. To evaluate and recommend training aids and methods of training enhancement.

F. To promote awareness and share information regarding new development trends in hunter education within the Association and with the hunter education organizations of other states.

G. To invite training experts to speak to the group on topics



relevant to Item A., Article I, Section 1.

H. This Association is organized exclusively for charitable, scientific, literary, or educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code

\$3000 for the conference committee.

Membership was discussed. Current membership is at 252. Mo-  
tion made to give away a free membership as a door prize at  
each regional picnic failed.

A new business affiliate "McGhee Training Services" has  
joined the Association. Motion made and approved for \$900 for  
the membership committee.

Newsletter was discussed and motion was made and approved  
for \$1500 for the newsletters this year.

Bylaws were discussed and a number of things were talked  
about. There will be a change to remove the Past President issue.  
Term limits are a topic for discussion. Members are asked to  
voice their opinion.

Discussion over adding additional deputy directors and proper

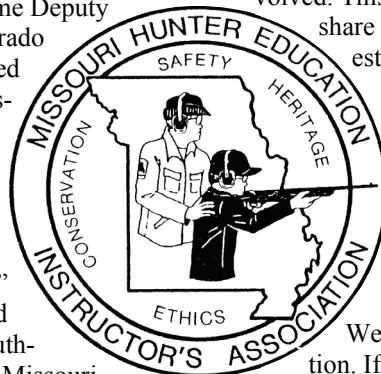
